1. The candidate must be citizen of India. They must have knowledge of Hindi/Sanskrit at matric or higher level.

 - **Physically Disabled - Exempted from fees**

3. The candidates belonging to the category of PH (PwD i.e. Person with Disabilities) will enclose necessary certificates with their application form from a Competent Authority in support of their claim of Disability. The type of disabilities should be notified clarify in the certificate as defined in the Govt. letter dated 25.04.2018.
 4. EWS certificate on prescribed proforma should be valid for the year in which the candidates have applied for the posts as per govt. instructions issued vide no. 22/12/2019-IGS-III, dated 14.01.2026. The EWS certificate should be issued after 31.03.2026 and valid for the year 2026-27. EWS certificate issued for jobs in Central Govt. will not be considered irrespective of income mentioned in certificate. Fresh EWS certificate will be required at the time of document verification and for further process. If a candidate fails to submit certificate as per above requirement, then he/she shall be considered under Un-reserved category, if they fulfill the eligibility condition/criteria of Unreserved category (UR).
 5. The appointment on contract shall be subject to Instructions and issued by the Government of Haryana from time to time regarding contractual appointment and no claim of regularisation/ extension of contract shall be entertained.
 6. The application fee is neither refundable not adjustable. Separate application form is required to be submitted offline for each post with prescribed fee.
 7. The required qualification and relevant experience etc. for eligibility shall be determined as on the last date of receipt of application.
 8. All qualifications must be attained from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible for consideration for any of the post advertised.
 9. If a Grade Point System is adopted the CGPA will be converted into equivalent marks. Provide the relevant document of conversion of CGPA into equivalent marks along with application form.
 10. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate to be called for written test/ interview.
 11. University may conduct written test/ skill test for shortlisting candidates if required.

Accordingly, unless such Degrees had been recognized for the period when the candidates acquired the relevant qualification, they will not be accepted for the purpose of Educational Qualification.
