3. Valid Category Certificate, wherever applicable (SC/BC/PH/ESM/FF, etc.).
4. Income and Asset Certificate (FY-2026) issued by Competent Authority of Haryana Government where applicable (EWS/TFW/BC-A/BC-B categories)
5. Copy of Parivar Pehchan Patra (PPP) for Haryana resident candidates.
6. Copy of Aadhaar Card and EPIC (Voter Identity Card).
7. Four recent passport-size photographs.
8. Relevant supporting certificates, wherever applicable (EWS/KM/TFW/HGST/SGC, etc.).
9. Admission fee (published on university website Vide Ref. No. SVSU/2026/AA/057, dated 24/5/2026) through Credit/Debit Card payment at the University admission venue. (Cash and cheque payments shall not be accepted).
10. Candidates in Schedule Caste category having income less than Rs. 2.5 Lakh (Verified PPP and Income Certificate FY 2026) are eligible for Post Matrix Scholarship and exempted for depositing of fee. (only Security amount will be deposited).

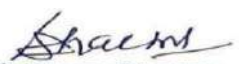
