Eligibility Criteria

Sr. No.	Programme Name	Eligibility
1.	Master of Business Administration (Working Professional)	Passed Bachelor's Degree of minimum 3 years duration from a recognized Board, University, or Institution and obtained at least 50% marks (45% marks in case of candidates of Haryana belonging to reserved category) in the qualifying examination and must possess at least One Year of valid post-qualification experience.
2.	Master of Laws (L.L.M.)	L.L.B or an equivalent degree from a recognized University with not less than 55% marks in aggregate (50% in case of reserved categories, i.e. SC/ST/Persons with Disability). The admission for Foreign Nationals shall be made on the basis of: (i) academic record of LL.B. or equivalent Degree recognized by UGC/ Association of Indian Universities with not less than 55% marks or equivalent grade. (ii) Assessment of necessary communication skills in written and spoken English and performance at the interview in terms of aptitude and capacity.
