Terms & Conditions

1. The sealed quotations, completed in all respects, must reach by post/hand in the office of the Registrar, Shri Vishwakarma Skill University, Takshila Bhawan, Main Campus, Dudhola, Palwal – 121102, Haryana, latest by the date and time specified below.
2. The quotation shall be submitted within 10 days from the date of publication of this NIQ on the University website. The exact closing date and time shall be treated as the date/time stated in the published NIQ.
3. "Zoom License integrated with Zoom Cloud Room Connector with IP Call Connectivity Facility – 100 User Capacity" must be clearly written on the sealed envelope.
4. The quotation received after the due date and time or incomplete in any respect shall be liable to be rejected outright.
5. The bidder should clearly mention: (a) F.O.R. charges, if any; (b) applicable GST/taxes/duties; (c) payment terms; and (d) validity period of the quotation.
6. All charges/costs must be clearly mentioned in the quotation. Charges not specifically mentioned in the quotation shall not be paid by the University.
7. F.O.R. shall be SVSU, Dudhola, Palwal.

8. TDS/GST/other applicable taxes shall be deducted by the University as per applicable Government rules/instructions.
9. Payment will be made after receipt/activation of the service/product and after satisfactory report from the concerned Inspection/Technical Committee.
10. Acceptance of the service/product shall be subject to a satisfactory report of the office's Inspection Committee/Technical Committee/Experts Committee, as applicable.
11. The acceptance of the quotation/tender shall rest with the undersigned, who does not bind himself to accept the lowest quotation and reserves the right to reject any or all quotations without assigning any reason. The University also reserves the right to accept the quotation in part and reject the remaining quantity/service.
12. The dispute, if any, shall be subject to the jurisdiction of the competent Court at Palwal. Any other jurisdiction mentioned in the quotation, invoice or documents of the manufacturer/distributor/dealer/supplier shall be invalid and shall have no legal sanctity.
13. Terms and conditions printed on the quotation of the firm, if any, shall not be binding on the University except those specifically accepted by the University in the supply/service order. Acceptance of the order shall be construed as agreement to all terms and conditions contained in the order.
14. The bidder shall clearly specify the validity period of the Zoom license, user capacity, included Zoom Cloud Room Connector facility, IP Call Connectivity facility, cloud storage and room-splitting features, and any other recurring or one-time charges.
15. The quoted price shall clearly indicate whether GST and all other applicable taxes/charges are included or excluded.
